RESOLUTION

WHEREAS, the State of Illinois requires that Building inspection departments conduct all plumbing inspections by a licensed plumbing inspector, licensed by the State of Illinois; and

WHEREAS, the long time licensed plumbing inspector has retired from the Lake County Building and Code Enforcement Division and no full-time plumbing inspector works for the Division currently; and

WHEREAS, the department agreed to un-fund the plumbing inspector position and attempt to hire a part-time inspector or find some other comparable means of providing licensed plumbing inspections, so that the position was not budgeted for FY 06; and

WHEREAS, the department has determined that the alternate part-time approaches can not provide the inspection service effectively and efficiently; and

WHEREAS, the residential and commercial building permit activity has remained at a high level thereby necessitating a full time licensed plumbing inspector; and

WHEREAS, the estimated building permit revenues will cover the cost of adding back the inspector position.

NOW, THEREFORE, BE IT RESOLVED by this County Board of Lake County, Illinois that an increase in the position inventory for the Planning, Building and Development Department is hereby authorized to add the position of Principle Building & Zoning Inspector with funding to be provided by additional permit revenues.
