WHEREAS, Rock River Service Company, Rockford, IL is the lowest responsive and responsible bidder for the Interview Room Recording System for Lake County in the estimated amount of \$25,782.00, other responsible bids were received from: DTT Surveillance, \$32,708.00, LaMar Systems, \$34,980.00, three (3) non-responsive bids were received from: Integrated Security Solutions, CDW, and GeoTek Industries; and
