RESOLUTION

WHEREAS, in accordance with Section 5-102 of the Lake County Purchasing Ordinance, proposals were called for by publication for establishing contracts with qualified providers for Youth Services to provide In-School and Out-of-School Programs under the Workforce Investment Act for the Lake County Workforce Development Department; and

WHEREAS, subsequent to said publication, request for proposals were extended to sixty-five (65) service providers; and

WHEREAS, a Workforce Development Board Selection Review Committee recommends awards be made to multiple service providers offering the most favorable proposals to Lake County to meet the diverse needs of the In-School and Out-of-School populations to be served; and

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Director of Central Services is hereby directed to enter contracts for In-School Youth Programs with Nicasa, Round Lake, IL for \$149,589.00 to service 25 youth; North Chicago High School, North Chicago, IL for \$139,177.32 to service 20 youth; North Shore Academy, Highland Park, IL for \$19,935.00 to service 15 youth, and SER-Jobs for Progress, Waukegan, IL, for \$113,078.49 to service 20 youth and contracts for Out-of-School Youth Programs with Daisy's Resource & Development Center, North Chicago IL, for \$118,829.29 to service 30 youth; Youth Build of Lake County, North Chicago, IL for \$134,280.63 to service 16 youth; First Institute, Crystal Lake, IL for \$149,678.90 to service 24 youth; and North Chicago Community High School/Bridges, North Chicago, IL for \$85,679.50 to service 15 youth charging the costs thereof to account #750-4042010-72680-000-000-000-Y2005 for one year plus renewals for Workforce Development.
