RESOLUTION

WHEREAS, County Board by and through its Division of Transportation has caused to be constructed a bike path along Robert's Road (*County Highway 35*) from east Lake Shore Drive to Circle Drive. Said bike path completed in November 2005 with the assistance of the Village of Tower Lakes; and

WHEREAS, this County Board of Lake County, Illinois, by prior resolution at its meeting of April 13, 2004, enacted an ordinance officially naming said bike path as the "Roberts Road Bike Path", pursuant to the statutory authority conferred to the County by the Illinois Compiled Statutes, as amended, 55 ILCS 5/5-1067; and

WHEREAS, in honor of the Mayor Leonard J. Kuskowski, the Village of Tower Lakes and Lake County are desirous of renaming said Roberts Road Bike Path to the "Leonard J. Kuskowski Bike Path"; and

WHEREAS, said Chapter 55 of the Illinois Compiled Statutes 5/5-1067 provides the authority for the County Board to effect said name changes.

ORDINANCE

SECTION 1: BIKE PATH NAME

The bike path located within the right-of-way of Roberts Road and/or upon permanent and perpetual easement granted and conveyed to the COUNTY's Division of Transportation, is hereby officially named the LEONARD J. KUSKOWSKI BIKE PATH pursuant to the statutory authority conferred to the COUNTY by the Illinois Compiled Statutes, as amended, 55 ILCS 5/5-1067.

SECTION 2: SIGNS

The County Engineer of Lake County, State of Illinois is directed to cause to be placed on said bike path appropriate signage designated said COUNTY bike path "LEONARD J. KUSKOWSKI BIKE PATH"

SECTION 3: EFFECT DATE

This ordinance takes effect immediately after adoption by the County Board.

SECTION 4: AMENDMENTS

This ordinance from time-to-time may be amended as seen fit by the County Board.

SECTION 5: REPEALER

Section 1 of the ordinance, adopted by the County Board, April 13, 2004, which named said bike path, is hereby repealed in do far as is necessary to effect the re-naming of the said bike path contemplated by this resolution.
