

RESOLUTION

WHEREAS, Lake County has 481 voting precincts in 18 townships; and

WHEREAS, Seth Paine Elementary School has served as a polling place for Ela Township precincts 78, 79, 86, 87, and 454; and Isaac Fox Elementary School has served as a polling place for Ela Township precinct 101; and Middle School South has served as a polling place for Ela Township precinct 104; and

WHEREAS, the Superintendent of Community Unit School District 95 has requested that Seth Paine Elementary School, Isaac Fox Elementary School, and Middle School South no longer serve as polling places; and

WHEREAS, the Community Unit School District 95 has offered use of the old Middle School North building located at 100 Church Street in Lake Zurich as a polling place for precincts 78, 79, 86, 87, and 454; and the Village of Deer Park has offered the use of a newly remodeled facility located at 23680 West Cuba in Deer Park as a polling place for precincts 101 and 104.

WHEREAS, the Gorton Community Center has served as a polling place for Shields Township precincts 251, 252, 253, and 254; and

WHEREAS, the Gorton Community Center will not be available for future November elections; and

WHEREAS, the Church of the Holy Spirit is a convenient location and is located at 400 East Westminster Road in Lake Forest and has agreed to serve as a polling place for precincts 251, 252, 253, and 254.

WHEREAS, the Buffalo Grove Village Hall has served as a polling place for Vernon Township precinct 293; and

WHEREAS, the Belmont Village located at 500 McHenry Road in Buffalo Grove is a more convenient location and has agreed to serve as a polling place for precinct 293.

WHEREAS, Wauconda High School has served as a polling place for Wauconda Township precincts 347, 350, and 351; and

WHEREAS, Wauconda High School will be undergoing renovation and unavailable as a polling place for the November 7, 2006 and April 17, 2007 elections; and

WHEREAS, the Wauconda Park District has agreed to provide the Community Center located at 600 North Main Street in Wauconda as a polling place for precincts 347, 350, and 351.

WHEREAS, the West Deerfield Township office has served as a temporary polling place for West Deerfield Township precincts 414 and 415; and

WHEREAS, the Deerspring Pool located at 200 Deerfield Road in Deerfield has completed their renovation and has agreed to again serve as a polling place for precincts 414 and 415.

WHEREAS, Congregation Beth Or has served as a polling place for West Deerfield Township precincts 427 and 428; and

WHEREAS, the Patty Turner Senior Center located at 375 Elm Street in Deerfield already serves as a polling place for precinct 425, is a more convenient location, and has agreed to accept precincts 427 and 428.

NOW THEREFORE BE IT RESOLVED, by this County Board of Lake County, Illinois, the attached "Exhibit A" sets forth the revised polling place assignments for the precincts described above, which are identified by their name and location.
