WHEREAS, sealed bids were received from seven (7) vendors and opened in the County Building, Waukegan, Illinois on Wednesday, August 16, 2006, at 2:00 p.m.; and

WHEREAS, Car-Min Construction Co., Inc, Waukegan, IL is the lowest responsive and responsible bidder in the amount of \$152,700.00 other responsive bids were received from: Truesdell Corp - \$159,900.00, Spectrum Contracting Corp. - \$156,154.00, Wisconsin Restoration, Inc - \$200,100.00, National Restoration Systems - \$208,166.00, Kovilic Construction Co.- \$226,500.00, and Design Installation Systems - \$353,988.00; and

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby directed to enter into a contract with Car-Min Construction Co., Inc., Waukegan, IL, in the amount of \$152,700.00, for Rehabilitation of the Concrete Balconies at the Belvidere Medical Building, including Add Alternate Item 1a, charging the costs thereof to account #101-1103285-82020-000-000-000-11121.
