

SPECIAL CALL MEETINGLAKE COUNTY BOARD PROCEEDINGSTHURSDAY, DECEMBER 14, 2006

The Lake County Board met in a Special Call Meeting held on Thursday, December 14, 2006 in the County Building in Waukegan, Illinois. Chairman Schmidt called the meeting to order at 9:05 a.m. and asked for a moment of silent prayer. The Chair led the Pledge to the Flag. County Clerk Willard Helander called the roll. Members present were: Calabresa, Carlson, Carter, Cole, Cunningham, Gravenhorst, Kyle, Leafblad, Maine, Martini, Mountsier, Newton, Nixon, O'Kelly, Paxton, Powers, Sabonjian, Schmidt, Spielman, Stolman, Talbett and Whitmore. Member Bassi was absent.

1. The Clerk read into the record the Presentation of the Call of the Special Meeting and Certificate of Mailing Notice of the Special Call Meeting.

Member Calabresa moved, seconded by Member Spielman to approve the Notice of Special Call. The Chair called for a Voice Vote on the motion. Motion carried unanimously.

2. Public Comment.

3. Resolution adopting the County Board Rules of Order and Operational Procedure as recommended by the Rules Committee.

Member Paxton moved, seconded by Member Gravenhorst to place the item on the floor. The Chair called for a Voice Vote on the motion. Motion carried unanimously.

Mr. Burton advised that this has always been implied, but we wanted to clarify and make it specific.
