RESOLUTION

WHEREAS, in accordance with Section 5-102 of the Lake County Purchasing Ordinance, proposals were called for by publication for establishing contracts with qualified providers for Youth Services to provide Out of School Programs under the Workforce Investment Act for the Lake County Workforce Development Department; and

WHEREAS, subsequent to said publication, request for proposals were extended to one hundred eighteen (118) service providers; and

WHEREAS, a Workforce Development Board Selection Review Committee recommends awards be made to multiple service providers offering the most favorable proposals to Lake County to meet the diverse needs of the Out of School populations to be served; and

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby directed to enter contracts for Out of School Youth Programs with; First Institute, Crystal Lake, IL for one hundred forty six thousand eight hundred eighty nine dollars and twelve cents (\$146,889.12) to service twenty one (21) youth; North Chicago School District 187/Bridges, North Chicago, IL for eighty eight thousand three hundred thirty seven dollars and seventy cents (\$88,337.70) to service fifteen (15) youth; North Chicago School District 187/CNA, North Chicago, IL for one hundred forty eight thousand five hundred seventeen dollars (\$148,517.00) to service twenty (20) youth, and Youth Build of Lake County, North Chicago, IL for one hundred forty nine thousand seven hundred seventy six dollars and seventy five cents (\$149,776.75) to service sixteen (16) youth; charging the costs thereof to account #750-4042021-79940-000-000-000-Y2007 for one year plus renewals for Workforce Development.
