WHEREAS, the Circuit Court Clerk has agreed to transfer to the General Fund \$1,800,000 for such projects using Court Document Storage Fund Balance; and

WHEREAS, there are sufficient funds available in the Court Document Storage Fund Balance 258-0000000-30010 to cover this emergency appropriation.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois that an emergency appropriation in the amount of \$1,800,000 for the Capital Improvement Program in 101-1103160-84040 and an emergency appropriation in the amount of \$1,800,000 in 258-3110010-79920 is hereby approved; and

WHEREAS, there will be a \$1,800,000 increase in the revenue budget 101-1103160-49920.
