WHEREAS, in accordance with the Evaluation Criteria as established in the Request for Proposals and the interview, the Selection Review Committee has determined that the proposal submitted by Daniel Robison Architects is the most favorable proposal for Lake County;

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Director of Central Services is hereby directed to enter into a contract with Daniel Robison Architects, Gurnee, IL in the amount not to exceed \$210,000.00 for Architectural/Engineering Design Services for the new Branch Court Facility in Park City, Illinois, charging the costs thereof to account #101-1103335-71150-000-000-00000, and request its adoption.
