


MADAM CHAIRMAN AND MEMBERS OF THE COUNTY BOARD:

**RESOLUTION**

WHEREAS, the Illinois Criminal Justice Information Authority (ICJIA) has announced the continuation of a 12-month grant in the amount of \$27,325 for the State's Attorney's Juvenile Accountability Incentive Block Grant/Juvenile Court Services program (Agreement #505002) to provide staffing to allow greater focus on violent juvenile offender prosecutions, and the reduction of overall case backlog; and

WHEREAS, the grant program will fund a portion of the salaries for two Assistant State's Attorneys in the Juvenile Division; and

WHEREAS, the program budget of \$170,793, as submitted to ICJIA, consists of \$27,325 federal funds, \$3,036 required matching funds, and \$140,432 in overmatch funds all of which shall be provided from the specified accounts outlined in the table below; and

WHEREAS, it is necessary to authorize the extension as described herein.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the renewal of the State's Attorney's Juvenile Accountability Incentive Block Grant/Juvenile Court Services program (Agreement #505002), in the amount of \$170,793 for the period beginning February 1, 2007 through January 31, 2008, is hereby accepted; and

BE IT FURTHER RESOLVED, that the Chairman of the Board, the Lake County State's Attorney, and the Lake County Treasurer are hereby authorized to execute the necessary documentation to accept the renewal; and

BE IT FURTHER RESOLVED, that grant revenue in the amount of \$27,325 from the ICJIA, \$3,036 matching funds from account 760-3318010, and \$140,432 matching funds from account 101-3300010, will be deposited in the appropriate revenue account; and

BE IT FURTHER RESOLVED, that the State's Attorney shall serve as project director for the program, and accurate records of all necessary grant compliance requirements shall be kept by the State's Attorney Office.
