RESOLUTION

WHEREAS, Lake County has 481 voting precincts in 18 townships; and

WHEREAS, single precinct polling places countywide are being consolidated into multiple precinct polling place locations which will make it easier for voters to be processed while providing a higher level of accuracy; and

WHEREAS, precincts are being relocated to polling places which have sufficient parking and space as well as full accessibility for all voters; and

WHEREAS, a few sites have declined to continue as a polling place or other sites are undergoing renovations requiring a new location for these affected precincts.

NOW THEREFORE BE IT RESOLVED, by this County Board of Lake County, Illinois, the attached "Exhibit A" sets forth the polling places assigned to the affected precincts, which are identified by their name and location.
