RESOLUTION

WHEREAS, in accordance with Section 5-102 of the Lake County Purchasing Ordinance, proposals were called for by publication for establishing contracts with qualified providers for Medical Claims Support Services consisting of case management services, vocational rehabilitation services, bill review, utilization review and ergonomic assessments; and

WHEREAS, subsequent to said publication, request for proposals were extended to twenty nine (29) service providers; and

WHEREAS proposals were received from nine (9) firms; and

WHEREAS, a Human Resources Selection Review Committee evaluated proposals and recommends awards be made to multiple service providers offering the most favorable proposals to Lake County to meet medical claims support needs; and

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby directed to enter into contracts for case management and vocational rehabilitation services with Encore Unlimited, Stevens Point, Wisconsin in the amount of \$25,000.00, charging the costs thereof to account #206-1440010-72180; for bill review and utilization review services with Genex Services, Inc., Schaumburg, Illinois in the amount of \$22,500.00 charging the costs thereof to account #206-1440010-71100; and for ergonomic assessment services with Bandes & Associates, Glenview, Illinois in the amount of \$7,500.00, charging the costs thereof to account #206-1440010-71530 for a two-year period, plus renewals.
