WHEREAS, sealed bids were received from five (5) vendors and opened in the County Building, Waukegan, Illinois on Monday, March 26, 2007 at 2:00 p.m.; and

WHEREAS, McDonough Mechanical Services, Inc., Waukegan, IL is the lowest responsive and responsible bidder for the Replacement of HVAC Air Handlers in the amount of \$393,268.00, other responsible bids received were from: M K Industries, \$407,492.00, Air Con, \$511,327.00, National Heat and Power Corp, \$576,000.00, Amber Mechanical Contractors, Inc, \$656,000.00.; and

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby directed to enter into a contract for Replacement of HVAC Air Handlers at the Lake County Health Department with McDonough Mechanical Services, Waukegan, IL. in an amount not to exceed \$393,268.00 charging estimated costs of \$243,683.00 to account 101-1103285-82020-000-000-000-11159, and \$149,585.00 to account 101-1103285-82080-000-000-000-11161 and request its adoption.
