## RESOLUTION

WHEREAS, in accordance with Section 4-102 of the Lake County Purchasing Ordinance, bids were called for by publication for a Bill Payment Remittance System for the Public Works Department; and

WHEREAS, subsequent to said publication, invitations for bids were extended to thirteen (13) firms; and

WHEREAS, sealed bids were received from four (4) vendors and opened in the County Building, Waukegan, Illinois on Thursday, March 15, 2007 at 2:00 p.m.; and

WHEREAS, RT Lawrence Corporation, of Santa Fe Springs, California is the lowest responsive and responsible bidder for the Bill Payment Remittance System in the amount \$44,907.00, the other bids received were from: Creditron in the amount of \$48,414.00, Net Advantage in the amount of \$49,563.40 and Fairfax in the amount of \$143,683 and;

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby directed to negotiate a contract with RT Lawrence Corporation, of Santa Fe Springs, California for a Bill Payment Remittance System in an amount not to exceed \$41,088.00, charging the total cost to account #610-4887799-84040-000-000-48310 and requests its adoption.
