## **RESOLUTION**

**WHEREAS**, the Nineteenth Judicial Circuit's Adult Probation division will be relocating to 215 Water Street upon completion of the remodeling project that is underway; and

**WHEREAS**, it is the intent that the new office space at 215 Water Street will improve work conditions for probation officers; and

**WHEREAS**, one such improvement important to the Nineteenth Judicial Circuit is that probation officers have adequate privacy when they meet with clients; and

**WHEREAS**, it is necessary that the probation officer cubicles have 85" panels and office doors to ensure this privacy; and

**WHEREAS**, given the current prices of modular office furniture, the capital budget for the remodeling of 215 Water Street does not allow for 85" panels or office doors; and

**WHEREAS**, an emergency appropriation in the Probation Service Fee fund in the amount of \$150,000 is needed to cover the additional expense that will ensure probation officer privacy; and

**WHEREAS**, any remaining funds will be used for enhancements such as technology upgrades for the training and group rooms at 215 Water Street; and

**WHEREAS**, there are sufficient funds in the Probation Service Fee fund balance 250-000000-30010 to cover this emergency appropriation.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that an emergency appropriation in the amount of \$150,000 of probation service fees in 250-3210010-84060-000-000-000-00000 is hereby approved.
