**WHEREAS**, Lake County, by and through its Map Services Department, has researched the roadway name residents presently utilize and recommend and support above said change; and


**WHEREAS**, Lake County has the power and authority to change the name of said street by virtue of 55 ILCS 5/5-1067.

**NOW, THEREFORE BE IT RESOLVED** that said Circle Drive South (*west of IL Rte. 83*) in Fremont Township be re-named "Kenmore Lane".

**BE IT FURTHER RESOLVED** that the County Engineer of Lake County is hereby authorized and directed to notify the Fremont Township Road District, the Lake County Map Services Department, the Lake County Recorder of Deeds, the County Clerk, the adjacent property owners of record, and the US Postal Office of said name change.
