RESOLUTION

WHEREAS, off-duty "special duty" details are those assignments established between the Lake County Sheriff's Office and private business, individuals, and governmental units within the County of Lake, and which are not part of the normal watch function; and

WHEREAS, effective May 1, 2006, the current rate for special duty patrol is \$70.00 per hour; and

WHEREAS, the Sheriff's Office and the Office of Finance and Administration have agreed this rate needs to be increased to better recover actual costs; and

WHEREAS, the two-tiered rate system was made effective May 1, 2005 which made a distinction between the rates charged for special duty services in unincorporated portions of Lake County and in those incorporated areas without a Police Department from the rates charged for special duty services in a municipality with a Police Department.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that: 1) the hourly rate for special duty patrol within the Sheriff's primary jurisdiction shall be \$73.00 per hour effective June 12, 2007, and 2) the rate for special duty patrol within a municipal police jurisdiction shall be \$90 per hour effective June 12, 2007.

BE IT FURTHER RESOLVED, that billing and collection for these services will continue to be performed by the Sheriff's Office with all collections deposited into 101-3001110-46290 Special Police Services of the Lake County General Corporate Fund. Deputies will be paid for special detail duties in payroll checks with the applicable deductions.
