RESOLUTION

WHEREAS, Lake County has 481 voting precincts in 18 townships; and

WHEREAS, a review of said precinct boundaries by the County Clerk's Office indicated that boundaries should be adjusted in a certain precinct; and

WHEREAS, adjusting the existing boundaries will establish boundaries which are consistent with statutory requirements and County Board policy; and

WHEREAS, it is recommended that West Deerfield Township Precinct 410 be adjusted to make Early Voting and Election Day voting convenient for unincorporated voters in said precinct; and


WHEREAS, to accomplish this, residents living in the unincorporated area of West Deerfield Township Precinct 410 will be added to West Deerfield Township Precinct 412; and

WHEREAS, after this adjustment, the resident's Early Voting location will be West Deerfield Township Office and their Election Day polling place will be Congregation B'nai Tikvah in Deerfield.

NOW, THEREFORE BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Ordinance Establishing Precinct Boundaries be amended to adjust the existing precinct boundaries of Precincts 410 and 412, effective immediately, and to describe and name said precincts in accordance with the attachments which are attached hereto and made part hereof this Resolution.
