



MADAM CHAIRMAN AND MEMBERS OF THE COUNTY BOARD:

WHEREAS, the County's Workforce Development Department is working with the United Way and other groups in the development of a website, www.findhelplakecounty.org, that will function as an information source for citizens and services providers; and

WHEREAS, a fund transfer is required in the amount of \$5,000.00 for activities associated with the Workforce Investment Board's support of a health and human services directory costs; and

WHEREAS, it is necessary to appropriate these funds in the Workforce Development Department budget.

NOW, THEREFORE BE IT RESOLVED, by this County Board of Lake County, Illinois that an emergency appropriation in the amount of \$ 5,000.00 in the Lake County Workforce Development Department budget be authorized; and

BE IT FURTHER RESOLVED, that the Lake County Workforce Development budget be modified to reflect the additional funds received.

BE IT FURTHER RESOLVED, that an emergency appropriation for expense fund 750-404253-71860 is hereby authorized.

**Find Help Lake County
Information Item**

- The United Way and Lake County have been working together on a plan to co-develop a single health and human services website directory for Lake County residents and service providers.
- The site would provide a single source for citizens and service providers to search when seeking human services in Lake County.
- Currently these services are listed in a wide variety of locations including Workforce Board Redbook, Health Department Resource Guides, 19th Judicial System Human Services Website, and the United Ways Resource Guide. The United Way will establish www.findhelplakecounty.org and administer the site in Lake County.
- Residents would be able to access the website and search for resources at no charge. Service providers will be able to register their programs and update their information regularly. The United Way will monitor the site and provide reminders to service providers to update their program information.
- The County would enter into an agreement with the United Way of Lake County for the website development, maintenance, outreach and community awareness activities.
- The agreement would be for a pilot three year time period, at a cost of \$10,000 per year, \$5,000 per year to be provided by the Workforce Investment Board and \$5,000 per year by the Health Department.
- Sufficient funds exist to in the department budget; however, an emergency appropriation is needed to move the necessary funds for the program. The United Way anticipates launching the website during Fall 2007: www.findhelplakecounty.org
