**WHEREAS**, the Nineteenth Judicial Circuit has a need to increase the staff in the Pretrial Services Division due to workload increases; and

**WHEREAS**, the Nineteenth Judicial Circuit anticipates an ongoing need for these positions; and

**WHEREAS**, the creation of these positions necessitates an emergency appropriation of \$29,787 to provide for the costs of said positions for the remaining pay periods of FY07; authorizing an interfund transfer of \$29,787 in offsetting revenue from 250-3210010-79920; authorizing an emergency appropriation from Probation Services Fee Fund Balance in the amount of \$29,787; and

**WHEREAS**, there is sufficient funding in Probation Services Fee Fund Balance to cover these positions.

**NOW, THEREFORE, BE IT RESOLVED**, by this County Board of Lake County, Illinois, that two full-time Grade 10 Probation Officer positions be created; and

**BE IT FURTHER RESOLVED**, that emergency appropriations in the General Fund be authorized in the amount of \$29,797; and

**BE IT FURTHER RESOLVED**, that an emergency appropriation be authorized in the amount of \$29,797 from Probation Services Fee Funds Balance; and

**BE IT FURTHER RESOLVED**, that an interfund transfer of \$29,787 of offsetting revenue from 250-3210010-79920 is authorized.
