RESOLUTION

WHEREAS, the County of Lake and the North Shore Sanitary District have entered into an Agreement for Sewage Disposal in connection with the Northeast Central Facilities Planning Area (NEC FPA); and

WHEREAS, Lake County has entered into collateral Agreements for Sewage Disposal with several municipalities within the NEC FPA; and

WHEREAS, the Agreement with the North Shore Sanitary District provides for adjustments in rates and charges of the District; and

WHEREAS, the North Shore Sanitary District has notified the County of an adjustment in the connection fee rate; and

WHEREAS, it is necessary for the County to provide a similar notice to the individual municipalities within the NEC FPA.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Villages of Gurnee, Grayslake, Hainesville, and the City of Waukegan be notified of a sewer connection fee increase in the amount of \$32.00 from \$565 to \$597 per population equivalent (P.E.) or equivalent thereto effective November 1, 2007.
