WHEREAS, in accordance with the Evaluation Criteria as established in the Request for Proposal and the interview, the Selection Review Committee has determined that the proposal submitted by NextGen Healthcare Information Systems, Inc., Horsham, Pa., is the most favorable proposal for Lake County;


