WHEREAS, sealed bids were received from nine (9) vendors and opened in the County Building, Waukegan, Illinois on Tuesday, September 18, 2007, at 2:00 p.m.; and

WHEREAS, Camosy, Incorporated, Waukegan, IL is the lowest responsive and responsible bidder in the amount of \$3,727,400.00 (plus unit priced excavation, if needed) other responsive bids were received from; Boller Construction, Waukegan, IL - \$3,802,000.00, A.J. Maggio, Mt. Prospect, IL - \$3,816,600.00, Happ Builders Inc., Waukegan, IL - \$3,829,300.00, Nicholas & Associates, Mt. Prospect, IL - \$4,036,000.00, Henry Bros, Hickory Hills, IL - \$4,102,225.00, Rasch Const.& Engineering, Inc., Kenosha, WI - \$4,170,500.00, Petra Construction Co., Lombard, IL - \$4,181,905.00, and one non-responsive bid was received from Budget Sign Company, Arlington Heights, IL, in the amount of \$10,577.28; and

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby directed to enter into a contract with Camosy Incorporated, Waukegan, IL, in the estimated amount of \$3,727,400.00, (plus unit priced excavation, if needed) for Construction of the New Branch Court Facility in Park City, IL charging the costs thereof to account #101-1103335-82010-000-000-000-000000; and requests its adoption.
