RESOLUTION

WHEREAS, Lake County has 481 voting precincts in 18 townships; and

WHEREAS, a review of said precinct boundaries by the County Clerk's office indicated that boundaries should be adjusted in certain precincts; and

WHEREAS, adjusting the existing boundaries will establish precincts which are consistent with statutory requirements and County Board policy; and

WHEREAS, it is recommended that the property located at 320 Roslyn Road, Barrington located in Cuba Township Precinct 74 be re-assigned to Cuba Township Precinct 77 to ensure voter privacy; and


WHEREAS, it is recommended that Libertyville Township Precincts 166, 167, and 178; Shields Township Precincts 241 and 244; and Waukegan Township Precincts 393, 394, and 400 be adjusted to conform closer to municipal boundaries; and

WHEREAS, after this adjustment, the precinct boundaries will comply with State Senator Terry Link's bill regarding Early Voting requirements; and

WHEREAS, these changes create more efficient Early Voting assignments for administration and tabulation purposes while also providing greater convenience and more simplified Early Voting assignments for voters; and

NOW, THEREFORE BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Ordinance Establishing Precinct Boundaries be amended to adjust the existing precinct boundaries of Precincts 74, 77, 166, 167, 178, 241, 244, 393, 394 and 400, effective immediately, and to describe and name said precincts in accordance with the attachments which are attached hereto and made part hereof this Resolution.


