Resolution

WHEREAS, the Lake County Board adopted a Resolution amending the fees relating to services provided by the Department of Planning, Building and Development and incorporating these fees into one Lake County Land Development Fee Schedule on November 9, 1999; and

WHEREAS, there were subsequent amendments to the Lake County Land Development Fee Schedule on November 13, 2001, January 14, 2003 and January 13, 2004 and March 8, 2005 and October 10, 2006; and

WHEREAS, the Lake County Board wishes to further amend the existing Land Development Fee Schedule for the Department of Planning, Building and Development to continue to provide such services; and

WHEREAS, the revised fees reflect the actual or lesser cost of providing services by the Department; and

WHEREAS, it is recommended that the Lake County Land Development Fee Schedule be amended in accordance with attached EXHIBIT A.

NOW, THEREFORE, BE IT RESOLVED by this County Board of Lake County, Illinois that:

SECTION 1. The Lake County Land Development Fee Schedule containing the Building Permit Fee Schedule, Site Development Permit Fee Schedule, Zoning Fee Schedule, ZBA Fee Schedule, Subdivision, Site Capacity/Site Plan Fee Schedule and the Plat/Street Vacation Fee Schedule is amended in accordance with EXHIBIT A.

SECTION 2. The Department of Planning, Building and Development shall collect fees for the services rendered by this Department in accordance with the Lake County Land Development Fee Schedule as hereby amended in accordance with EXHIBIT A (attached).

SECTION 3. This Resolution shall be in full force and effect on December 1, 2007.

DEPARTMENT POLICY

All applications for permits and approvals shall be accompanied by the fee established in this Lake County Board policy below. All applicants, including Home Owners Associations, religious organizations, units of government, and no-for-profit organizations, shall pay the fee as part of the application process. Only those specifically exempted by state law are exempt from the fee schedule.
