RESOLUTION

WHEREAS, the Department of Commerce and Economic Opportunity has provided a Program Year 2007 grant for the Workforce Investment Act to the Lake County Workforce Development Department in the amount of \$75,541; and

WHEREAS, the State of Illinois has awarded Lake County a \$75,000 grant to implement the state's rebranding program called ILWorkNet; and

WHEREAS, the State of Illinois has increased the incentive grant award by \$541 due to a miscalculation of the original award which was adopted at the June 12, 2007 Lake County Board meeting; and

WHEREAS, it is necessary to approve an emergency appropriation in the amount of \$75,541 for the Lake County Workforce Development Department fiscal year 2007 budget to allow the expenditure of funds and authorize acceptance of the Workforce Investment Act grants.

NOW, THEREFORE BE IT RESOLVED, by this County Board of Lake County, Illinois that an increase in the amount of \$75,541 in the Lake County Workforce Development Department revenue account be authorized for account number 750-4042010-45333-000-000-000-Y2007; and

BE IT FURTHER RESOLVED, by this County Board of Lake County, Illinois that an emergency appropriation in the amount of \$75,541 in the Lake County Workforce Development Department budget be authorized. A chart of accounts will be provided to the Controller in a timely manner.
