Title

Joint Resolution authorizing an emergency appropriation in the amount of \$341,574 for the Lake County Workforce Development Department

Staff Summary

- The Department of Commerce and Economic Opportunity has increased the Program Year 2008 grant for the Workforce Investment Act to the Lake County Workforce Development Department by an additional \$191,574 bringing the total budget to \$4,467,602.

- The Department of Commerce and Economic Opportunity has increased the Trade Adjustment Assistance grant for Program Year 2008 by an additional \$150,000 bringing the total budget to \$200,000.
- The total budget increase is \$341,574.

Body

WHEREAS, the Department of Commerce and Economic Opportunity has increased the Program Year 2008 grant for the Workforce Investment Act to the Lake County Workforce Development Department by \$191,574; and

WHEREAS, the Department of Commerce and Economic Opportunity has increased the Trade Adjustment Assistance grant for Program Year 2008 by \$150,000; and

WHEREAS, as a result of the above actions it is necessary to increase the overall appropriation by the amount of \$341,574 for the Lake County Workforce Development Department budget; and

NOW, THEREFORE BE IT RESOLVED, by this County Board of Lake County, Illinois that an emergency appropriation in the amount of \$341,574 be approved for the Lake County Workforce Development Department; and

BE IT FURTHER RESOLVED, that the total budget for WIA for PY 08 is \$4,467,602 and for Trade Adjustment Assistance is \$200,000. A chart of accounts will be provided to the Controller in a timely manner.
