Please note the following clarifications, revisions, and additions to the bid documents.

REQUESTS FOR INFORMATION and REVISED BID FORM

- 1. Question: Is steam allowed as a curing method for liners? It seems to be a great fit with the lack of water/hydrant access. Response: Technical Specification Section IV Sanitary Sewer Lining - 4.04 Execution - B.4. Installation is hereby revised to include steam curing as a method for curing liners in the sewer main. Section VIII Service Later Connection Lining - 8.04 Execution - B.3. Installation of the technical specifications already allows steam curing for lateral liners.
2. Question: On page IV-5, Item 2 - Testing - There is a cost associated with independent testing and it's unclear if we'll be required to perform these tests. Would you consider adding a line item for this test so we know if/how many tests to include in our costs? Response: Remove and replace the existing bid form with revised bid form per Addendum #2, which includes new Bid Item 21. Bid Item #21 is added for Field Quality Control Tests as described in Section IV Sanitary Sewer Lining - 4.04 Execution - C. Field Quality Control 2. Testing for the testing of the cured liners. If a test fails, additional testing may be required by the owner at the expense of the contractor.

 - g) Bidder has given ENGINEER written notice of all conflicts, errors, ambiguities, or discrepancies that Bidder has discovered in the Contract Documents and the written resolution thereof by ENGINEER is acceptable to Bidder, and the Contract Documents are generally sufficient to indicate and convey understanding of all terms and conditions for performing and furnishing the Work for which the Bid is submitted.
