Public notice is hereby given that sealed Bids will be received at the Lake County Purchasing Division office located at the Lake County Central Permit Facility, ATTN: PURCHASING DIVISION, 500 W. Winchester Rd., Libertyville, IL 60048 until 2:00 p.m. on June 6, 2013, for the following:

**Bid Number 13157 Project Name: ROOF REPLACEMENT AT THE DIVISION OF TRANSPORTATION, 600 WEST WINCHESTER ROAD, LIBERTYVILLE, IL 60048** for Lake County

**Project Description:** The intent of the project is to provide labor, materials, equipment, and tools to furnish and install a new roof at 600 W. Winchester Road, Libertyville, IL, on a portion of existing Bldg. A, the Admin. Bldg. There are several roof sections in the project scope, totaling approximately 3,770 SF. The scope includes the removal of the existing roof at these areas. New roofing membrane will be an EPDM membrane, fully adhered.

**A pre-bid conference will be held at Lake County Division of Transportation, 600 West Winchester Road, Libertyville, IL 60048 at 8:00 a.m. on Tuesday, May 14, 2013. Pre-bid attendance is not mandatory, but recommended.**

A 10% security deposit must accompany the bid. The successful bidder must furnish a satisfactory performance bond and a payment bond each in the full amount of the bid.

All work performed under this contract shall be in accordance with the laws of the State of Illinois, including but not limited to the Illinois Employee Classification Act, the Wage Determination of the Secretary of Labor, provisions of the Illinois Prevailing Wage Act 820 ILCS 130 et seq., and the Illinois Workers on Public Works Act, 30 ILCS 570/ et seq, including Public Act 096-0929 signed into law June 16, 2010. With respect to the Illinois Workers on Public Works Act, the level of unemployment in the State of Illinois has exceeded 5% for two (2) consecutive calendar months.

Lake County, in accordance with the laws of the State of Illinois, hereby notifies all bidders that it will affirmatively insure that the contract entered into pursuant to this advertisement will be awarded to the lowest responsive and responsible bidder without discrimination on grounds of race, color, or national origin.
